

**INITIAL MEMORANDUM OF UNDERSTANDING**  
**BETWEEN**  
**KISARAZU CITY, CHIBA PREFECTURE, JAPAN**  
**AND**  
**FEDERAL MINISTRY OF YOUTH & SPORTS, FEDERAL REPUBLIC OF NIGERIA**

The purpose of this MEMORANDUM OF UNDERSTANDING is for Kisarazu City and Federal Republic of Nigeria, hereinafter referred to as “both parties”, to state their intention to enter into a collaboration regarding pre-2020 Tokyo Olympic and Paralympic Games training camps, hereinafter referred to as “the training camps”.

**I**

**Implementation of the Training Camps**

The training camps will be held in Kisarazu City prior to the Tokyo 2020 Olympic and Paralympic Games, hereinafter referred to as “the games”.

**II**

**Host Town & Community**

Kisarazu City will act as the Official Host Town of Federal Republic of Nigeria during the games.

Nigerian team will, to the greatest degree possible, engage in activities such as welcome reception, friendship exchanges with kisarazu City community on off time of training.

**III**

**Use of Facilities**

During the training camps, to the greatest degree possible, Kisarazu City will provide Nigerian team with sporting facilities for the purpose of training.

#### IV

##### Expenses

The following shall be the basis for determining expense allocations on costs related to the games. Details shall be discussed between both parties concerned and mutually concluded in writing and signed with other documents by both parties.

Type of expenses	Allocation
International travel expenses, lodging expenses, food expenses, medical expenses, relevant insurance premiums, etc.	Federal Republic of Nigeria
Domestic transport expenses (Narita/Haneda-Kisarazu-The Olympic Village) , transport expenses shuttling from a hotel-training spots etc, security expenses, event facility usage fees, expenses involving volunteers such as training support, etc.	Kisarazu City, Japan


##### Conclusion of an Agreement

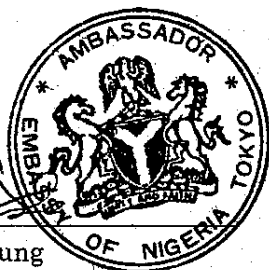
Both parties agree to sign a further agreement, which will outline the details of the training camps collaboration.

#### VI


##### Other
